Apostille

An Apostille refers to the legalization of a document for use internationally under the 1961 Hague Apostille Convention. All member countries to the Hague Apostille Convention may simply receive an Apostille certification to authenticate documents for use in a foreign country. A specific country is required for this document.

Business Entity Copies Certified

Certified copies of documents (i.e. Certificates of Incorporation; Articles of Organization; Applications for Authority; Certificates of Registration, etc.) filed with the state agency (such as the Secretary of State). Additional fees may apply.

Business Entity Copies Plain

Uncertified (Plain) photocopies of documents (i.e. Certificates of Incorporation; Articles of Organization; Applications for Authority; Certificates of Registration, etc.) filed with the state agency (such as the Secretary of State).

Business Entity Kit/Supplies

Returned together, or singularly, options include Interest Certificates, Business Entity Seals, Stock Certificates, Unit Certificates, and Member Certificates.

Certificate of Fact

This is a Certificate that represents a specific transaction. Examples would be a Cert Re (Certificate Reciting): Merger; or Cert. Re: Amendment. This document is typically used as a supporting document to accompany business entity documents being filed in other states.

Child Support Judgment Lien Search

A search to determine if there are child support judgment liens filed against an individual.

Franchise Tax

A search done with the taxing body of a business entity (such as the Division of Taxation or Revenue) indicating whether the business entity is up to date with its business entity taxes. (Note: This report/certificate is not available in all jurisdictions.)

Good Standing/Legal Existence Certificate Long Form

Conclusive evidence from the issuing agency (such as the Secretary of State) that the business entity is in existence as of a specified date. The long form typically specifies the filings of record along with the dates when the filings were recorded. (Note: Long Forms may not be available for all jurisdictions, and additional fees may apply.)

Good Standing/Legal Existence Certificate Short Form

Conclusive evidence from the issuing agency (such as the Secretary of State) that the business entity is in existence as of a specified date. Depending on the jurisdiction, the document may include information regarding the standing of the business entity and other details such as: date of formation/qualification; registered agent and office; and the date of the last annual report filing.

Legalization of Documents

Certifying and legalizing documents for foreign countries that are non-members of the Hague Apostille Convention require additional authentication steps. These additional steps include obtaining a Non-Hague certification by the Secretary of State where it is executed, (some states may require that the documents be certified by the County Clerk first), then certified by the U.S. Department of State, and then certified by the applicable Embassy. A country is required for this order.

Litigation Searches-Specific County

This search includes the following records: Bankruptcy; Federal Tax Liens; State Tax Liens; Judgments from general courts of jurisdiction; and Lawsuits from general courts of jurisdiction. A brief abstract is provided for any records found. A specific county is required for this search.

Litigation Searches-Statewide

This search is a statewide database search that includes the following records: Bankruptcy; Federal Tax Liens; State Tax Liens; Judgments from general courts of jurisdiction. A brief abstract is provided for any records found. This search is not limited to a specific county, and does not include effective dates.

Name Availability

This is a search to determine if an entity name is available for use in a given jurisdiction, or multiple jurisdictions. One to three names can be provided. A Name Availability search only demonstrates if a name can be used -- it does not also reserve that name for use. In order to protect the name, you can order our Name Reservation product.

Name Reservation

This is a document that can be filed to protect a business entity name for a certain period of time (i.e. anywhere from 30 days to 1 year).

NJ Court Judgment Copies Certified

Certified copies of judgments filed with the New Jersey Superior Court Clerk's Office in Trenton, or transferred to the Trenton archives. (We do not retrieve Judgments or Case copies from the New Jersey County Superior Courts.)

NJ Court Judgment Copies Plain

Uncertified (Plain) photocopies of judgments filed with the New Jersey Superior Court Clerk's Office in Trenton, or transferred to the Trenton archives. (We do not retrieve Judgments or Case copies from the New Jersey County Superior Courts.)

NJ Docket Sheet Retrieval

This is a document that lists case history or actions for a specific case.

NJ Lower Court Search

This search includes the following records: Federal Tax Liens; Federal District Court Lawsuits; NJ Judgments filed with the Special Civil Part Division of the Superior Court; NJ Lawsuits filed with the NJ Law and Special Civil Part Divisions of the Superior Court. This search is typically ordered by customers who have already ordered a NJ Certified Upper Court Search.

NJ Release of Judgment

A photocopy of a NJ Release of Judgment that has been filed to vacate or cancel a judgment.

NJ Release of Property

A photocopy of a NJ Release of Property that releases the property from the judgment.

NJ Warrant of Satisfaction

A photocopy of a NJ Warrant of Satisfaction that has been filed to satisfy a judgment.

Non-Hague Certificate

Non-member countries to the Hague Apostille Convention would receive a Non-Hague Certification and the document would require additional steps to be legalized for use in a foreign country. See "Legalization of Documents".

Patriot Name Search

Non-Certified Search of lists published by the Office of Foreign Assets Control of the U.S. Department of Treasury ("OFAC"), consisting of the "Specially Designated Nationals and Blocked Persons", the "Foreign Sanctions Evaders", and the comprehensive "Consolidated List".

Status/Information Report

An uncertified information report with filing details from the issuing agency (such as Secretary of State). Depending on the jurisdiction the report may provide some of these details: the date of filing; the state of formation; the status of the entity; the registered agent and registered office; the date of the last annual report filing.

Trade Name Search & Retrieval

A non-incorporated entity such as a sole proprietor or general partnership may file a Trade Name at the county level. A search can be conducted at the county level to see if there is a Trade Name on file. A county is needed for this search.

UCC w/Listing Only

A Uniform Commercial Code debtor search to determine if there are any liens against the debtor. A listing of any liens found is provided. (This search does not provide copies)

UCC w/Copies

A Uniform Commercial Code debtor search to determine if there are any liens against the debtor. If UCC liens are found the Revised Article 9 compliant copies are provided.
